5. Communications

5.1 Retiree Recognition/Teacher of the Year Recognition

The North Kitsap School District Board of Directors wishes to recognize our amazing retirees who have dedicated their careers to supporting the education of children in North Kitsap. Thank you for the many years of service.

Debbie Nazarino, President of the Teacher of the Year Organization presented the Teacher of the Year award to Barbara Pixton and Peggy Dunbar.

5.2 Superintendent Comments

- Thank you to all the staff that has served the children in the North Kitsap School
 District. It all takes a lot of heart and they do it because they love children and
 want to serve our community.
- Yesterday was the deadline to sign up for summer school. Our K-8 program had 280 students sign up for summer school, which is the largest ever. Secondary

- sign ups were advertised a little late so we did not get enough students to offer enrichment classes but we will begin advertising earlier next year.
- WAKIDS is required for all day Kindergarten schools, and it appears now that
 four or five of our schools may be funded for all day Kindergarten. Teacher
 training will be required. There is a three day waiver for Kindergarten student's
 that is automatic to allow parents and teachers time to meet and discuss prekindergarten for each of the students.
- The legislature is still up in the air. Both house and senate are discussing additional funds for K-2 or K-3 and could potentially change our staffing at the elementary schools.
- We had 1400 participants in the Thought Exchange process and we will be getting the overview out to the public on Tuesday. Our principal's and staff have had a chance to look at the results so that they could discuss feedback received. As a leadership team we will be reviewing the comments for themes both positive and negative at a future retreat.

5.3 Public Comments

Laura Kessler made public comments regarding concerns about cuts to the Agate Program.

Claudia Alves made public comments regarding recognition of Barbara Pixton as an Educator of Poulsbo Elementary School.

5.4 Legislative Report- Superintendent Page

- The Legislature continues to meet. The House was in session today and a very important House Bill 2214 that deals with assessments was passed that will allow a waiver of the Biology EOC for students that do not pass since the test will no longer be offered. This will still affect some students this year.
- Another bill was introduced House Bill 6130 that would change the
 compensation of educators. Senator Rolfes is a sponsor of this bill. The bill is
 very confusing and would start in 2018/2019, which would be the transition
 year. It modifies the school districts from using levy funds for staff salaries. It
 changes the definition of basic education and brings in salaries under basic
 education. There are no revenue sources that have yet been identified to
 support the bill.

5.5 Board Comments

Beth Worthington excused Bill Webb and Cindy Webster-Martinson from tonight's meeting. Beth was in attendance at the Kingston Highs Choir Concert, Honoring Ceremony with the Tribe, KHS Senior Award banquet, Mad Hatter Art Display at NKHS, and the Pearson Elementary Play. Research was done on how to improve government transparency.

Scott Henden's youngest son is graduating this year. He can see what efforts the teachers have made for every student. If you have students in the school please share the good stories about the teachers with the Board

Bruce Christen discussed a book by Ken Robinson "Creative Schools" it is a great book and I highly recommend that you read it. It is about the personal nature of education and excerpts of the book were read. The book Finnish Lessons 2.0 written by Pasi Sahlberg is also recommended. GRM, the Global Reform Movement is discussed in the book. The District's mission statement was read into record.

I am a parent of an AGATE student who will be going into the 5th grade next school year. My son (Kahn) has finally landed in a atmosphere where his gifts are recognized and nurtured and, is by all accounts, successful. He has been successful in great part to the special attention he was able to receive. This attention was not just an outstanding teacher in Ms. Taylor, Ms Taylor's collaboration with Ms. Fairchild but also, the attention which can only be achieved by a <u>reasonable</u> class size.

The program will suffer (as to will my son's education) should you carry through with the plan to **not** have a specifically "5th grade only" class roster. Though the 3rd/4th grade class is soon to be behind us, not having 2 instructors to share that load could (and likely will) only serve to limit the long term outcome and overall effectiveness of the AGATE program.

You as board members have got to see that these AGATE kids, which the state has spent thousands upon thousands of dollars in administrative time to seek out and recognize, could have a serious roll in our planets future....... this is why they were sought out to begin with! Further, I am not exaggerating their importance by one iota! I am not usually emotional about this kind of stuff and generally choose not to get involved but, this is real and this is important.

You have something good in this current model that seems work perfectly. It would be short sighted to diminish the ability of this model in anyway. Ask yourself: Are you willing to short the world the next Bill Gates?, Steve Jobs? or Barack Obama because of a minor budget crunch?

Work it out, get creative, ask for help, write a letter, sell cookies......fix it!

I'll pitch in. You want money? You want time? You want me to bake cookies? tell me!

Thank you for taking time in your already busy agendas to consider the needs of some of the most unique children in our district: those in the AGATE program at Suquamish Elementary. I understand that we are waiting anxiously for the state to decide on a budget and that will answer many questions for next year. The message that you and other school officials have shared is that we should remain calm and patient; that there are many uncertain elements regarding next year. In light of all of those things, I do believe that now is a good time to let you know how the AGATE program has impacted my family.

I would like to start by saying that this past year has been amazing for my kids in the AGATE program with three teachers. I currently have a 5th and 3rd grader enrolled in the program. My 5th grader was in AGATE in 2013-2014 with two teachers, and now in 2014-215 for my 3rd and 5th graders with three teachers. Although both years were exceptional, there was a dramatic improvement this past year. The depth of the program with 3 teachers was astounding. The play that they were able to produce hit so many curriculum areas and was such a rich learning experience. I know that this type of project is just not possible in a 2 classroom model. Switching back and forth between a 2 and 3 teacher model is not sustainable. We should be growing our program. Perhaps our program needs to be considered a stand alone program with a staffing allocation separate from Suquamish Elementary's?

I'm confident that you are aware of the negative impact recent constricting changes to state law have had on our program. Enrollment in AGATE is bound to decline with each age group as students tend to move in our area, and are not backfilled by other similar children. But there are so many under-served kids in our district. This seems like a unique opportunity to maintain a fabulous program and better serve more children. What changes can we make to this awesome program to ensure that we are serving the maximum number of kids possible? Are we able to recruit kids? Would it be possible to include 4th or 5th grade kids that were on the cusp of making the highly-capable bar, or who declined enrolling in the 3rd grade?

There would seem to be multiple ways to ensure adequate enrollment in this program and maintain the amazing quality we have achieved with three teachers and classes.

Thank you for your time and commitment to our kids. I know that we can reach a solution that will benefit as many students as possible.

Dear School Board Members:

I'm writing to you to express my concern with the changes currently scheduled to affect the AGATE Program in the 2015-2016 school year. My son, Gabriel, is a third grader in the program and has grown exponentially in his AGATE classroom this year. The program has been a blessing for us because I was beginning to lose hope that we could find a way to meet my son's needs in the North Kitsap School District.

After two very challenging years at Suquamish Elementary, my son was finally diagnosed with a myriad of developmental disabilities by private practitioners. However, these were masked for many years by his strong cognitive abilities. This nets out to him being "twice-exceptional". Most professionals advised that we seek private school education for him because public schools have difficulty serving these types of children, but I was determined to make things work (or at least exhaust all possibilities). To understand the system and education methods better, I got a Masters degree in Teaching and volunteered countless hours at the school. While this prevented many negative social experiences for him, it didn't help him directly with his social inabilities. Nor did it help him with his dysgraphia which was a great disability in the AGATE classroom which relies heavily on writing.

We spent the first half of the year figuring out how to address his writing issues. Finally, with the help of an amazing team (Karen Knezevich, Heidi Breisling, and Sarah Taylor) he began working on his writing in the Resource Room and growing his mind and spirit in the AGATE classroom for the rest of his work. Once Gabriel became comfortable with writing in the Resource Room and his anxiety began to fade, something magical happened. For the first time since he has been in public school, he knew his classmates names. At the end of the day, he was even able to tell me some of the exciting projects they had been working on at school. He was socially engaged and a part of him that had previously been so stunted began to flourish. It was the type of growth that I had always hoped for but didn't dare expect. To know that he would be able to continue next year where he left off, with the same teacher-team, left me full of hope and joy. 4th grade would be the first year that he wouldn't waste the first 3 months trying to remember the morning routine or the bathroom policy. He could just start learning from day one.

As you can imagine, my heart sunk when I learned that Sarah Taylor may not be his teacher for next year. While Gabriel's experience may not be identical to other students' in the classroom, I know that many will be impacted in a similar way. In addition to the continuity of learning being interrupted for students, some of the other impacts of this decision are as follows: AGATE teachers are able to provide more enriching, project-based lessons when there are 3 teachers rather than just 2; The 3 year AGATE curriculum has been planned with the support of 3 classroom teachers. Reducing the numbers of teachers will directly impact the continuity and quality of the program; with fewer teachers, opportunities for differentiation, especially for the math curriculum, will be reduced; and, with a strong enrollment in the 3-4 grade classroom for the coming year, there is a strong likelihood that the program will require a third teacher the following year (2016-2017). Removing Sarah Taylor from the teaching team will significantly stifle program development.

As this decision has not been finalized, I ask that you consider any options possible to keep the AGATE teaching team strong. Perhaps a few more highly capable incoming 5th graders who haven't been identified by testing could fill in the 5th grade class? Is there grant money or money available to bridge the gap during this temporary time? I am confident that if this becomes a priority, an solution can be found.

Thank you for your commitment to our schools and taking the time to consider my concern. This is such an amazing program and we are so thankful to be part of it!

Dear School Board Members:

I write to you today in order to briefly outline my family's experience with the AGATE program at Suquamish, and to plead with you to preserve the integrity of this world-class program by limiting class size and maintaining the exemplary teaching team of Mrs. Fairchild and Mrs. Taylor.

My family moved to the Pacific Northwest three years ago from one of the poorest, coal-mining counties in Pennsylvania, where I worked as a journalist and my husband taught English in a small liberal-arts university. In contrast to the depressed county we had left in the east, we were delighted with Kitsap County's clean water and air, more progressive attitudes, and of course, the natural beauty with which this region is so gifted.

What surprised us was, that despite the quality of our three daughters' committed teachers' guidance, Kitsap County schools were dramatically underfunded--much more so than our previous economically depressed region in Pennsylvania! Bigger class sizes, lack of money, and program cuts shocked us. Despite the school's financial difficulties, however, our girls found a good educational home here in Poulsbo--all except our middle daughter, Elspeth, who showed signs of being severely under-challenged. She began drifting to the nurse's office during the school day, a pattern we soon recognized was a result not of illness but of boredom. We wrung our hands--what was to be done for our slightly quirky kid who begged for extra homework?

Then we found the AGATE program. This year, Elspeth blossomed. She feels excited to get on the bus to go to school and she is fulfilled and happy at the end of each day. She has not minded extra homework--in fact, she has flourished! We owe her excellent teacher, Mrs. Fairchild, a great debt--her teaching style promotes independence, creativity, ingenuity, and courage. Elspeth engages in

serious work. Her mind and imagination have deepened as well as her reading, math, science, and critical-thinking skills.

I believe the AGATE program is unique and inherently valuable, not just to Elspeth, but to countless students who find their voice and their confidence to be great learners and critical thinkers. The AGATE program produces truly amazing citizens—young people who not only grapple with difficult algebra problems but who are aware of injustice in their own world and communities and who will, as adults, strive to make the world better with their gifts. (Our daughter, Merry, is enrolled in the AGATE program in Poulsbo Middle School, and we admire the same focus on academics and moral courage in her classes as well.)

The interdynamic action across disciplines and between Mrs. Fairchild and Mrs. Taylor, as well as the smaller class sizes, makes AGATE a program I proudly tout to many. The AGATE program is truly world-class--its curriculum is focused and intense and the team teaching and cooperation between two gifted and visionary teachers attests to its high standing in the world of elementary academia. As a high school English teacher some years ago, the private preparatory high school where I worked in Missoula, MT, decided to become more cutting-edge and competitive by adopting a new model-interdisciplinary teaching. We traveled to a preparatory school in Seattle to learn from their model. I see this model exemplified excellently by Fairchild and Taylor. I observe this not only through Elspeth's daily testimonials and achievements but through my own observation during classroom visits and once as a presenter sharing my own experiences growing up in Kenya during an African simulation--one of the many innovative experiences Elspeth has been privileged to participate in over this past school year. It would be a great disservice to students to dissolve the wonderful teaching partnership between Mrs. Fairchild and Mrs. Taylor--the old adage that two is better than one is absolutely true in this case.

As a board, your actions are limited by funding and other larger forces--I realize that. My husband, an administrator at Olympic College, understands that as well. But I would entreat you to think creatively about solutions that would preserve the AGATE program as it is now--a truly magnificent place of learning, challenge, and development.

Thank you for your attention to this matter and indeed for all the tireless work you perform on the behalf of our community.



Due to low enrollment for the 2015-2016 year, it has been proposed that the North Kitsap AGATE Program teaching staff should be reduced from three teachers to two. This would leave only two classrooms to serve at least 57 students with a class size of 28 and 29, respectively. We, the undersigned, are deeply concerned about the impact of the class size on program quality and respectfully request that you reconsider this proposal. Since this is a temporary low enrollment, three teachers will likely be needed the following year and Mrs. Taylor may not be available to teach if she takes another position. As parents, we are deeply vested in this program and request that you take measures to help the program grow, not diminish. Sadly, we cannot rely on Washington state to protect the best interest of our students by keeping class sizes low, so we hope that the North Kitsap School School Board and Administration will make if a priority.






